In an effort to insure that potential applicants have the most up-to-date information to allow them to prepare for application to the PTA Program, the program has provided this proposed point system. Note that this points system is pending as the program awaits a decision regarding a proposed change to the KCTCS Rules of the Senate; this change is anticipated in the fall semester.

The official, approved system should be in place prior to the first pre-admission conference of the fall semester, currently scheduled for October 1, 2014. Details about that conference are given below:

All students planning to apply to the SCC PTA Program in 2015 MUST attend a Pre-Admission Conference in the 2014-2015 academic year.

The deadline for application is 5:00 PM (EDT) on April 1, 2015.

Pre-registration is not required to attend pre-admission conferences.

Exceptional high school students in their final year of high school are encouraged to apply.

**ADMISSIONS PREFERENCE GROUPS**

The PTA Admissions Committee has determined that the groups below may receive preference from highest preference group to lowest preference group. Within the preference groups, the point system will be used.

As indicated on the Admissions Point System, there are three categories of applicants:

- I. Applicants in Category I have completed 12 or more college credits that may be applied toward the PTA degree (consisting of the ten general education courses). The GPA will be derived only from courses in the PTA General Education Sequence.
- II. Applicants in Category II are applicants that have graduated from high school, but have not completed twelve or more college credits that may be applied toward the PTA degree (consisting of the ten general education courses) prior to applying to the program.
- III. Applicants in Category III are applicants that have received their GED, but have not completed twelve or more college credits that may be applied toward the PTA degree (consisting of the nine general education courses) prior to applying to the program.

Preference Groups (from highest (1) to lowest (3)).

<b>PREFERENCE GROUP 1</b>
<ul style="list-style-type: none"><li>• For Applicants in Category I: ACT <math>\geq 19</math> <u>and</u> college GPA, derived only from courses in the PTA General Education Sequence <math>\geq 3.00</math>.</li><li>• For Applicants in Category II: ACT <math>\geq 19</math> <u>and</u> high school rank of 90% or higher.</li><li>• For Applicants in Category III: ACT <math>\geq 19</math> <u>and</u> 20 points from Admissions Points System based upon points awarded for performance on GED.</li><li>• Applicants who have completed a prior 4-year degree in any field from an accredited institution (that is, an institution from which SCC will accept credit) OR has graduated with a 2-year degree from any Somerset Community College Health Program are also included in Preference Group I.</li></ul>
<b>PREFERENCE GROUP 2</b>
<ul style="list-style-type: none"><li>• For applicants in Category I: ACT <math>\geq 19</math> <u>or</u> college GPA, derived only from courses in the PTA General Education Sequence <math>\geq 3.00</math>.</li><li>• For Applicants in Category II: ACT <math>\geq 19</math> and high school rank of 75% - 89%.</li><li>• For Applicants in Category III: ACT <math>\geq 19</math>, but less than 20 points from the Admissions Points System based upon points awarded for performance on GED.</li></ul>
<b>PREFERENCE GROUP 3</b>
<ul style="list-style-type: none"><li>• For Applicants in Category I: ACT <math>&lt; 19</math> and GPA derived only from courses in the PTA General Education Sequence <math>&lt; 3.00</math>.</li><li>• For Applicants in Category II: ACT <math>&lt; 19</math> and high school rank <math>&lt; 75\%</math>.</li><li>• For Applicants in Category III: ACT <math>&lt; 19</math> and less than 20 points from the Admissions Points System based upon points awarded for performance on GED.</li></ul>

*In addition, preference may be given to: Kentucky residents and applicants from the college service area; applicants who present verifiable documentation of employment as a physical therapy aide or technician, related healthcare experience, or related healthcare education; applicants providing a letter of recommendation from a PT or PTA; applicants residing in areas underserved by the profession or in regions where no PTA Program exists.*

*\*Only the highest ACT composite score will be used in determining points. Multiple scores are not averaged.*

*\*\* Points for work experience must be as a physical therapy technician / aide with supervision by a physical therapist. Internships performed as a clinical requirement in a related field may be considered, at the discretion of the Admissions Committee, if performed in a physical therapy setting. Completion of a PT Aide/Technician Certification Course will count as one year's experience.*

**Additional points awarded:**

Prior application to program: 1 point

Prior placement on alternate list: 1 point

*Minimum of 12 hours of required general education courses completed prior to applying to program.*

*-Points awarded for courses taken MUST be completed and on the applicant's transcript prior to the April 1 application deadline.*

*-If applicant is transferring college credit from another institution, credit is awarded only for courses that transfer in as the appropriate corresponding course as determined by the SCC Admissions Office and/or Registrar. Points for courses completed will not be awarded for courses that do not transfer in as the appropriate corresponding course.*

*-For applicants who were home-schooled, the GED and ACT must be completed in order to be considered for a position in the program if the applicant has fewer than twelve college credits in the PTA General Education Sequence.*

*-Preference may be given to students residing in areas underserved by the physical therapy profession or regions where no PTA Program exists or to those providing letters of recommendation from physical therapists or physical therapist assistants.*

*-Applicants graduating from high school in 2014 may elect to be viewed as either high school students or college students.*

***INTERVIEW PROCESS***

All PTA Program finalists are required to participate in a formal interview process. The interview is a panel interview with the program's Admissions Committee. The purpose of the interview is to evaluate the applicant's affective skills (communication abilities, professional demeanor, etc.) and their knowledge of the profession. The intent is to improve student retention by admitting students who exhibit a good knowledge base of the profession and key characteristics vital to success in the field of physical therapy. All students will receive the same questions and will be scored based upon the content of their responses. Questions will focus on:

- The applicant's general knowledge of the profession of physical therapy, work settings, challenges of the profession, and role of the APTA;
- The applicant's understanding of the roles of the physical therapist and physical therapist assistant and their professional relationships;
- The applicant's rationale for the selection of physical therapy as their profession of choice;
- The applicant's knowledge of the PTA Program's curriculum and requirements associated with clinical and didactic experiences; and
- Other areas related to the profession and to the applicant's personal successes and challenges.
