Every classroom phone has 911 capabilities. Security cell phone numbers are also published in the school newspapers and posted in areas that students travel. In addition the college safety manual describes to employees that it is college policy to report any and all crime to local 911. Somerset Community College has also installed the SNAP emergency notification system to allow students, faculty and staff quicker notification of any emergency on campus. Students can also notify any of the Campus Security Authorities. We are also including the process for reporting a crime in the Student Handbook, college website and by student e-mail.
